REQUIREMENTS AND INSTRUCTIONS

- Kansas is an electronic title state. An Add Lien or Replacement title is not printed due to the lien (loan) listed on the vehicle record. If a lienholder is shown on the registration receipt, there is a lien/loan on the vehicle record. **ONLY VEHICLES WITH NO LIEN HOLDER WILL HAVE A PAPER TITLE ISSUED.**
- Signature(s) of the owner(s) must match the name(s) on the face of the current Kansas title record. (The registration receipt will also show the name(s).)
 - To remove on existing lien, a notarized lien release is required.
 - Record the name and address of the secured party/lienholder, if applicable.
 - A copy of the security agreement is NOT necessary.
 - If a legal document or power of attorney is used, please attach it to the application.
 - Incomplete information and/or missing signature will VOID this application.
 - The current Kansas title* must be attached to this application for remove lien from paper title. The current Kansas title* or etitle registration receipt must be attached to this application for an add lien title. *If the current paper title has been lost or destroyed, must complete the Replacement Title Certification above.
 - Vehicles with a GVWR of 26,000 lbs or LESS CANNOT use this form to add a second lien. Please use the Refinance Secured Title Application, form TR-720R.
